Clyde Township has installed a secure drop box for taxes at the Township Hall.

The Mail slot is located at the rear of the building – labeled “Mail”. Taxes (either money order or checks) may be deposited in the mail slot. A receipt will be mailed.

Taxes are no longer to be paid at any private residence in Clyde Township.

Taxes may be paid in person on appointed days only as noted below:

The Township Treasurer will be at the Township Hall (back office) on the following dates and times to collect taxes:

December 2015

December 12 – 8:30 am until 11:30 am

December 28 -- 9:00 am until 5:00 pm**

January 2016:

January 9 – 8:30 am until 11:30 am

January 23 – 8:30 am until 11:30 am

February 2016:

February 13 – 8:30 am until 11:30 am

February 16 – 9:00 am until 5:00 pm (last day without incurring any interest or penalty)**

February 29 – 9:00 am until 5:00 pm (last day without becoming delinquent to county)**

****Closed between 12:00 and 1:00 for post office and banking duties.**

Starting February 17, 2016, taxes paid will incur a 3% late fee penalty. Please calculate the 3% on total tax amount only. Do not include administration fee in the penalty calculation.

Please do not try to pay taxes at the Allegan County Treasurers office. Allegan County cannot accept local taxes. Taxes must be paid in Clyde Township until March 1, 2016.

This website is updated with Clyde Township Tax information monthly.

Delinquent Property Tax Notice: A Delinquent Property Tax Notice is listed on any tax bill turned over to Allegan County on March 1, 2015 as delinquent. The notice is located in the Property Information section of the tax bill. Delinquent tax notices were mailed out by Allegan County in April 2015. This is a reminder there is still a balance due to Allegan County as of November. Local Treasurers cannot collect delinquent taxes, please call Allegan County Treasurer's Office at (269) 673-0260 for final balance due and payable to "Allegan County Treasurer".

The State Tax Commission has mandated that 20% of properties in Clyde Township be visited each year to review assessment record accuracy. This includes verifying property improvements, taking current digital photos of the property. Letters will be sent to property owners at least two weeks in advance of the physical inspections. Included will be a questionnaire regarding improvement information, to verify the accuracy of the data on file with the township. If a property owner does not want to grant permission for staff to access to their property, please send this request to the township in writing.
