Approved minutes of the Clyde Township Budget Hearing – February 12, 2025

The annual budget hearing of the 2025-2026 Budget of the Clyde Township was held at the Township Hall on Wednesday, February 12, 2025. The meeting was called to order at 6:30 p.m.

Audience: None

Roll Call: Members present – Bob Larsen, Bernie McLeod, Chris McKellips, and Pam Onken. Members Absent – Tommie Giles.

A motion made by Onken, supported by McLeod to appoint Larsen as chairperson of the meeting in the absence of Giles. Motion carried.

The proposed 2025-2026 budget was presented. Some budget items remained the same as the 2024-2025 budgets with the following exceptions:

- 1. <u>101-171 Supervisor Salary</u> Increase from \$20,700 to \$23,100
- 2. <u>101-101 Transportation</u> Increase from \$50 to \$100
- 3. <u>101-191 Salary</u> Decrease from \$6,000 to \$2,500
- 4. 101-191 Supplies Decrease from \$2,000 to \$500
- 5. 101-202 Assessor Services Increase from \$31,200 to \$33,900
- 6. 101-215 Clerk Salary Increase from \$32,700 to \$32,700
- 7. 101-253 Treasurer Salary Increase from \$31,800 to \$33,000
- 8. 101-253 Equipment & Repairs Decrease from \$2,500 to \$1,000
- 9. 101-265 Insurance Increase from \$24,000 to \$26,000
- 10. 101-971 Capital Outlay Increase from \$4,000 to \$200,000
- 11. 101-276 Cemetary Salary Increase from \$1,400 to \$1,800
- 12. 101-336 Supplies Increase from \$19,750 to \$41,850
- 13. 101-336 Repairs & Maintenance Increase from \$12,000 to \$28,500
- 14. 101-336 Vehicle Payment Decrease from \$22,100 to \$0
- 15. 101-446 Repairs & Maintenance Increase from \$141,600 to \$159,500
- 16. 101-446 Repairs & Maintenance Excess of Millage Decrease from \$108,400 to \$94,000
- 17. 101-838 Drains at Large Increase from \$15,000 to \$16,000

2025-2026 Expenditures Increased from \$831,900 to \$1,050,800 and Revenues were set at \$1,050,800
