Taxes must be mailed to: Clyde Township Treasurer P.O. Box 671, Fennville, MI 49408

Clyde Township has a secure drop box for taxes at the Township Hall.

The Mail slot is located at the rear of the building – labeled “Mail”. Taxes (either money order or checks) may be deposited in the mail slot. A receipt will be mailed.

Please do not try to pay taxes at the Allegan County Treasurers office. Allegan County cannot accept local taxes. Taxes must be paid in Clyde Township until March 1, 2024.

Taxes may be paid in person on appointed days only as noted below:

The Township Treasurer will be at the Township Hall (back office) on the following dates and times to collect taxes:

December 2023

Saturday, December 16 – 8:30 am until 11:00 am

Friday, December 29 – 9:00 am until 5:00 pm**

January 2024:

Saturday, January 13 – 8:30 am until 11:00 am

Saturday, January 27 – 8:30 am until 11:00 am

February 2024:

Saturday, February 10 – 8:30 am until 11:00 am

Wednesday, February 14 – 9:00 am until 5:00 pm (last day without incurring any interest or penalty)**

Thursday, February 29 – 9:00 am until 5:00 pm (last day before becoming delinquent to Allegan County)**

****Closed between 12:00 and 1:00 for post office and banking duties.**

Please note when paying in person exact change is appreciated. No more than \$20 will be given in change for tax payments.

Property taxes may be paid online with a 3% processing fee or \$3.00 for Electronic Check. Credit cards will be taken at the window during the above posted office hours. Otherwise you may pay online anytime by going to the Clyde Township website at www.clydetwp.com or www.clydetwp.net. There will be a link to the Point & Pay Program on front page of website: Pay Property Taxes Online

Starting February 15, 2024, taxes paid will incur a 3% late fee penalty. Please calculate the 3% on total tax amount only. Do not include administration fee in the penalty calculation.

Property Fraud Alert – Is your property protected from Fraud? Allegan County is now offering a free service to property owners of Allegan County. Property Fraud is when a fraudulent document is recorded in the county land records office. Allegan County has teamed up to create a notification service called Property Fraud Alert. Delinquent Property Tax Notice: A Delinquent Property Tax Notice is listed on any tax bill turned over to Allegan County on March 1, 2023 as delinquent. The notice is located in the Property Information section of the tax bill. Delinquent tax notices were mailed out by Allegan County in April 2023. This is a reminder there is still a balance due to Allegan County as of November 2023 for your 2022 property taxes. Local Treasurers cannot collect 2022 delinquent taxes, please call Allegan County Treasurer's Office at (269) 673-0260 for final balance due and payable to "Allegan County Treasurer".

Ambulance Service:

The Fennville Area Municipalities (including Clyde Township) entered into an ambulance contract with LIFE EMS Ambulance Services. Any resident wishing to sign up for LIFE Care Plus (Ambulance Membership Program) should contact LIFE EMS at (800) 499-9316 or go to www.lifeems.com for more information on this optional ambulance coverage. The annual fee is \$49 for residents with insurance or \$79 for residents without insurance.

ELECTION INFORMATION - The passage of Proposal 2 in 2022 mandated 9 days of early in person voting for state/federal elections. Clyde Township has joined the City of Fennville, Ganges Township, Manlius Township and Lee Township and will be conducting the 9 days of early voting at Fennville City Hall, 125 South Maple Street. For the Presidential Primary Election on February 27, 2024, the 9 days of early voting will begin on February 17th and end on February 25th. The hours of early voting will be 8:00-4:00 each day. Election Day voting on February 27th will still take place at Clyde Township Hall. We will also need more election inspectors.
